

ORDINANCE NO. 2025- 02

**AN ORDINANCE OF THE TOWN OF QUINTANA, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD FOR THE TOWN OF QUINTANA, TEXAS, ON THE 3RD DAY OF MAY, 2025; AND CONTAINING FINDINGS AND PROVISIONS RELATED TO THE SUBJECT.**

**WHEREAS**, on February 12, 2025, the Town Council of the Town of Quintana, Texas, (the "Town") adopted Ordinance No. 2025-01, which ordered that a general election be held for the Town on Saturday, May 3, 2025, for the purpose of electing a Mayor and two (2) Council Members; and

**WHEREAS**, said election was called and notice was given in accordance with the requirements of law, and the election was held in all material respects in conformity with law; and

**WHEREAS**, the returns of such elections have been duly and legally made and submitted to the Town Council, and the Town Council has examined such returns, including the tabulation attached hereto as Exhibit A and made a part hereof for all purposes;

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF QUINTANA THAT:**

**Section 1.** All of the recitals contained in the preamble to this Ordinance are found to be true and are adopted as findings of fact by this Town Council including, particularly the tabulation of returns of the election set out in Exhibit A.

**Section 2.** The Town Council now formally canvasses the returns of such election, and it is hereby adjudged, determined and declared that:

- (1) **Mike Cassata**, with a total of 7 votes cast for him, has been elected **Mayor** of the Town of Quintana, Texas for a term of two years; and
- (2) **Sue Tuley**, with a total of 3 votes cast for her has been elected **Council Member Position No. 1** of the Town of Quintana, Texas for a term of two years; and
- (3) **Stephen Alongis**, with a total of 7 votes cast for him has been elected **Council Member Position No. 2** of the Town of Quintana, Texas for a term of two years.


**Section 3.** The City Secretary is hereby authorized and directed to make the appropriate entries of information in the election register maintained by the Town in accordance with provisions of Section 67.006 of the TEXAS ELECTION CODE.

**Section 4.** If any word, phrase, clause, sentence, paragraph, section or other part of this ordinance or the application thereof to any person or circumstance, shall ever be held to be invalid or unconstitutional by any court of competent jurisdiction, the remainder of this

ordinance and the application of such word, phrase, clause, sentence, paragraph, section or other part of this ordinance to any other persons or circumstances shall not be affected thereby.

**Section 5.** The Town Council officially finds, determines and declares that a sufficient written notice of the date, hour, place and subject of each meeting at which this ordinance was discussed, considered or acted upon was given in the manner required by the Open Meetings Law, as amended, and that each such meeting has been open to the public as required by law at all times during such discussion, consideration and action. The City Council approves and confirms such notices and the contents and posting thereof.
