

ORDINANCE 2026-03

AN ORDINANCE OF THE CITY OF QUINTANA, TEXAS, CALLING FOR THE ANNUAL GENERAL ELECTION OF OFFICERS FOR THAT CITY IN CONJUNCTION WITH A JOINT ELECTION WITH OTHER POLITICAL SUBDIVISIONS IN BRAZORIA COUNTY, TEXAS; ESTABLISHING THE QUALIFICATIONS OF CANDIDATES FOR PUBLIC OFFICE; PROVIDING FOR THE SUBMISSION OF CANDIDATURES AND OATHS OF ALLEGIANCE FOR CANDIDATES AND SETTING A DEADLINE FOR SUBMISSION TO ACCOMPANY SUCH APPLICATION; PROVIDING FOR THE RATIFICATION AND CONFIRMATION BY THE MAYOR OF SAID CITY OF THE PROVISIONS OF THIS ORDINANCE; AND SETTING A DATE FOR THE EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF QUINTANA, TEXAS:

Section 1. Call for Annual General Election. Pursuant to the provisions of Section 22.03 et seq., the Texas Local Government Code, as amended, and the provisions of the Texas Election Code, the Mayor and City Council of the City of Quintana (the "City"), hereby order and direct, respectively, that an annual election be held on the first Saturday in May 2026, being the day of May 2, 2026 A.D., between 7:00 a.m. and 7:00 p.m., for the purpose of electing the following appointed officers of the People, namely:

Alderman Position 3 -	currently held by Camille Tyner
Alderman Position 4 -	currently held by Adam Valadez
Alderman Position 5 -	currently vacant

Section 2. Municipal Precinct and Polling Place. For purposes of the Annual General Election called by this ordinance, the election will be conducted in accordance with the Joint Election Agreement and Election Services Agreement with Brazoria County (the "County"). The Mayor shall be authorized by this Ordinance to enter into the Joint Election Agreement by executing the same.

The Town shall be deemed one (1) voting precinct and the County shall designate qualified persons to serve as Election Day Presiding Judge and Alternate Presiding Judge for the Election Day polling place.

Polling places on Election Day are attached hereto as Exhibit "A".

The early voting clerk will be appointed by the County. Early voting by personal appearance shall be conducted at the following locations or such other location as the County may determine:

April 20-24	8 AM – 5 PM
April 27-28	8 AM – 5 PM

Section 3. Candidates and Applications.

Alderman: Any person who has attained eighteen (18) years of age, and who has resided within the incorporated limits of the City of Quintana, Texas for a period of six (6) months prior to the last day on which a candidate's application for a place on the ballot may be delivered to the City Clerk, as provided below, shall be eligible to become a candidate for the office of Alderman for Township Positions 3, 4, and 5 by submitting a written affidavit containing the matters set

forth in Section 141.031, Texas Election Code, to the City Clerk of the Town, no earlier than 8:00 a.m. on Wednesday, January 14, 2026, and no later than 5:00 p.m. on Friday, February 13, 2026.

Section 4. Qualified Electors.

All qualified voters in the city will be allowed to vote in that election. Notwithstanding anything to the contrary in this ordinance, the election shall be conducted in accordance with the Texas Election Code and the Voting Rights Act of 1965, as amended, and as required by law. All election materials and procedures will be printed in English and Spanish. In addition, standard voting information pamphlets will be provided in English and Spanish, and the County will make arrangements with election officials for the use of Spanish interpreters, if needed. It is determined that these measures will adequately serve any Spanish speaker eligible to vote in the election.

Section 5. Notice of Election.

The Mayor of the City is hereby authorized and directed to issue notice of such election. The form of the notice prescribed by the Texas Secretary of State's Office shall serve as proper notice of such election. Such notice, including Spanish translations thereof, shall be given by publication or posting in accordance with Section 4.003 of the Texas Election Code.

Section 6. Date of Entry Into Force.


This ordinance will go into effect immediately upon its passage and approval.
